HISTORY & OVERVIEW

When the World Health Organization declared the Coronavirus (COVID-19) a pandemic, United Way of Sheboygan County's (UWSC) board and staff leadership quickly organized, invested in, and launched a Sheboygan County COVID-19 Relief Fund on Saturday March 14, 2020. The fund was intended to provide flexible resources to nonprofit organizations in Sheboygan County working with community members who were disproportionately impacted by coronavirus and the economic consequences of the outbreak. The Relief Fund gained continued momentum with Sheboygan Service Club (SSC) and UWSC announcing their partnership to co-lead the effort on April 22, 2020. For the first time in SSC's history, they mobilized funds from their endowment to support the relief effort. Both organizations have a long history of supporting and lifting the social sector through their annual events and fundraising efforts. By joining forces, SSC and UWSC amplified community support during unprecedented times. Funds were awarded as quickly as they were raised from the launch date through July 2020. A Fund Distribution Team, made up of SSC members and UWSC Board members, met weekly to review applications. A total of \$285,176 was raised and awarded during this time to 32 local agencies.



GRANT AWARD DETAILS

American Red Cross (\$5,542)

Provide antibody testing at Sheboygan blood donation sites

Anchor of Hope (\$1,500)

Provide essential baby items, including diapers, wipes, and car seats

BabyCare (\$3,000)

Provide diapers, wipes and essential baby items

Big Brothers Big Sisters (\$8,100)

Funds for microgrants to families in need of financial assistance but do not qualify for other assistance programs and to support costs of recruiting new volunteers

Boys and Girls Club, Mental Health America, and Nourish Collaboration (\$11,075)

Support collaborative approach to provide youth with summer activity kits

Support the comprehensive services program (food pantry, utility assistance) and wellness center program (prescription medication assistance) as community needs increase

Sheboygan County Food Bank (\$26,000)

Purchase food and hygiene items for distributing to community members in need.

Supplies for handwashing stations for 55 Farmers Market vendors

Sheboygan Halfway House (\$5,000)

LOCAL SURVEY RESULTS

IN JULY 2020 WE SURVEYED LOCAL NONPROFITS AND HERE ARE THE RESULTS:

- % nonprofits reported from some to severe financial negative impacts
 - 34 % saw staff reduction
- 74 % had to reduce volunteers
- 84 % saw between some and negative impact on fundraising
- % received funding from CARES Act
 - 30 % received additional State/federal funding

THE NEED

The Sheboygan County COVID-19 Relief Fund was developed to support local Sheboygan County nonprofits in their missions servicing our neighbors in need. Food, shelter, mental health, education, transportation, and overall health and safety measures are some of the many needs met through this Relief Fund.

According to the Helen Bader Institute, nonprofits employ one in twelve individuals of our workforce reflecting over 14 billion in annual wages in Wisconsin. Nonprofit agencies, like many sectors, have been significantly impacted by COVID-19.

Nonprofits are facing various challenges such as the increase in need/clients utilizing services, the decrease of in-person revenue services and special events, and the escalated costs for health and technology needs to best serve their clients. Funding through the COVID-19 relief fund focused on those direct service needs.

To assist in the grant-making process, the Fund Distribution Team members of both United Way of Sheboygan County (UWSC) and Sheboygan Service Club (SSC) participated in the weekly Nonprofit COVID-19 Response Network calls to better understand local needs.

Nonprofit COVID-19 Response Network, hosted by UWSC, provides a virtual meeting place for all local nonprofits to support each other in navigating the pandemic by sharing resources, best practices, and finding innovative ways to serve those in need. This network continues to meet and UWSC will survey, monitor, and share out local needs to funding partners like SSC and all interested community stakeholders.

Funding recovery for loss of special events revenue was a secondary overall social sector need that the Sheboygan County COVID-19 Relief Fund didn't address. Both UWSC and SSC have continued to support and fill those needs across the social sector through their respective ongoing fundraising and special event efforts.

IMPACT STORIES

YOUTH

Runaway Youth Services (RAYS) Program

Success story: There was a 15-year-old boy that relied on the RAYS Pantry and free school meals during the school year. RAYS staff noticed he did not have transportation and was likely not utilizing the school summer meals program. Staff reached out to all contacts available listed for him and all were not in service. The next time he was riding a bicycle and stopped by RAYS staff asked about food. He shook his head while looking at his bicycle and avoiding eye contact. The staff member informed him that RAYS has the ability to deliver food to where he is staying and, with a smile, he stated that would be great. The boy then identified two other ageeligible youth staying where he was and the staff was able to arrange delivery of food and hygiene items for all of them on an ongoing basis.



Thanks to funding from the Relief Fund, RAYS is able to provide food security for these children and many more.

MENTAL HEALTH

Catholic Charities

Success story: In the early months of the pandemic, a Spanish speaking woman in her 60's was feeling anxious and panicked about the coronavirus. Both her age and underlying health conditions put her at high risk for severe illness and death from COVID-19. With so many unknowns and confusing information, her stress and isolation became overwhelming. She called Catholic Charities and began meeting with one of their bilingual therapists. They talked through options of what she could do to regain some sense of control, like avoiding large crowds, wearing a mask when she needed to go out, frequent hand washing, and connecting with loved ones by phone as much as possible. They also discussed her daily routine and starting hobbies at home to stay active and positive. Having the ability to speak to someone in her language who understands her culture, helped her develop trust with the therapist, and set realistic goals that supported her well-being. Following the plans they put in place, she's managing much better and feeling less stress and anxiety.

Catholic Charities' bilingual therapists meet daily with people who - for a variety of reasons including poverty, lack of access to resources, language, and social barriers - are disproportionately impacted by the health and economic effects of COVID-19. Funding from the Relief Fund was essential to provide the Spanish speaking population with access to high quality, culturally competent mental health services.



Lakeshore CAP | Rental Assistance Program

Success stories:

In December 2019, a mother stopped working due to pregnancy concerns. After having her baby mom started a new job at a skilled nursing facility. Just weeks into her new job COVID caused her to lose child care for her newborn and subsequently had to leave her job. Rental assistance provided by Lakeshore CAP was instrumental in maintaining housing for this new Mom as she worked to obtain childcare and new employment.

A single Dad, with two elementary-aged children, was employed at a fast-food restaurant when the pandemic started. He was not able to maintain his normal work schedule because work had shortened all employees' work hours and this affected his pay that already was minimal. He knew they were struggling to make it before COVID-19 but now he needed immediate assistance with rent. With support from Lakeshore CAP, he was able to catch up and maintain the apartment, their home, and offered time to inquire and seek other resources for his family.

Lakeshore CAP continues to support families like above thanks to the ongoing community support, such as funding through the Relief Fund.


